### **JOB REQUIREMENTS FOR INVESTIGATORS**

#### **Eligibility Criteria:**

- Candidate should be a Graduate in any discipline.

#### **Scope of Work:**

- Investigators would be engaged for primary data collection work from Moradabad & other areas. The requirement of Investigators involves travel in both rural and urban areas.
- Any other work related to project as required in the area of data collection, analysis and field investigation.

#### **Selection Procedure:**

- All eligible candidates appearing for the Walk-In Interview will be interviewed in MHSC on the date, time and address as specified below: -

**Interview Date: 22<sup>nd</sup> November 2018**

**Time: 11:00 am to 3:00 pm**

**Address: Metal Handicrafts Service Centre, Peetal Nagri, Rampur Road, Moradabad (U.P.)**

(Note: It is the responsibility of the candidates to ensure that they are eligible before appearing for the interview)

- Selection among the eligible candidates will be done based on their resume and performance in the interview. Candidates having prior experience of primary data collection work will be given preference.

Note: No TA/DA will be paid for attending the interview.

#### **Remuneration:**

- Investigators will be paid a consolidated remuneration of Rs. 12,000/- per month, inclusive of local travel cost
- Cost borne towards any travel outside the city limits of Moradabad as required will be paid upon submission of the supporting travel documents and subject to prior approval

#### **Time Frame for Contract:**

The investigators will be engaged purely on contract basis initially for a period of upto 3 months.
